

Newcastle School of Drums - Privacy Policy

Our Privacy Policy sets out the different areas where user privacy is concerned and outlines the obligations and requirements of the users, the website and website owners. It additionally describes how your personal information is collected, used, and shared when you visit or fill in a contact form on our website / social media and also when you interact with us through email and phone exchanges.

Who is Newcastle School of Drums?

Newcastle School of Drums is an educational facility dedicated to delivering first class music education to the northeast, through drum tuition on its premises, as well as showcases and workshops at various music venues in the city of Newcastle Upon Tyne. Newcastle School of Drums (collectively referred to as 'Newcastle School of Drums, 'NSOD' 'we', 'us', and 'our' in this Privacy Policy) is the controller and responsible for your personal data collected through www.newcastleschoolofdrums.co.uk (the 'site').

How do we use your personal data?

We take the protection of your personal data seriously and will process your personal data fairly, lawfully and transparently. This policy describes the personal data we are collecting about you and how it is used. We collect and use your data for the following purposes, to: contact you in regards to organising drum lessons, give you a better user experience, improve our services, and meet our legal responsibilities.

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information."

When filling in our "booking enquiry" form, we may use this contact information to contact you in regards to organising drum lessons by using your email address or phone number provided. After enrolling in drum lessons, we will use your contact information to contact you in regards to lessons and send invoices.

Sharing Your Personal Information

Information about our customers is important to our business. In compliance with laws we may collect, use and retain your information. We may from time to time, offer competitions and giveaways through our social media accounts (collectively "Our Promotions"). Participation in Our Promotions is completely voluntary. Information will be requested from winning entrants and this may include personal contact information such as name, address, and similar details. We will never share, rent or trade your details with any other business or organization.

Third Parties

Finally, we may also share your Personal Information to comply with applicable laws and regulations, a lawful request for information we receive, or to otherwise protect our rights.

Your personal information is kept private and stored securely until a time it is no longer required or has no use, as detailed in the Data Protection Act 1998. Your details are not passed on to any third parties.
